INSTRUCTIONS

Florida Corporate Income Tax Credits will be issued in accordance with Section 220.192, Florida Statutes, on a first-come, first-served basis, based upon the date complete applications are received and upon availability of funding.

COVER SHEET

- **Summary Eligible Expenditures:** Provide a total for each category which applicant is seeking a Florida investment tax credit.
- **Applicant Certification:** Applicant must sign to certify compliance with Section 220.192, F.S.
